






Research Funding data 2018-2019

Research funding in the Division of Cardiology has increased 53% over the past 5 years and 52% in the past year.



The 5-year publication rate for members of Division of Cardiology is **300 publications per year** and an average rate of citations is more than 4500 per year with nearly 20 citations per publication.
